MEMORANDUM CIRCULAR No. 05
Series of 2016

SUBJECT: CREATION OF SPS TECHNICAL WORKING GROUPS

WHEREAS, pursuant to Republic Act No. 10611 otherwise known as the "Food Safety Act of 2013" Rule 12.b8, the Department of Agriculture (DA) and the Department of Health (DOH), in consultation with the Bureau of Customs (BOC), shall develop the regulations and set the parameters of the inspection and clearance procedures of imported food shipments. The inspection and clearance procedures shall be conducted by the DA and the DOH within their respective jurisdiction.;

WHEREAS, as stated under Rule 12h.9, the approved regulations shall be subject to periodic review and amendment as necessary;

WHEREAS, there is the need to create a Special Task Force that shall evaluate, monitor and inspect agricultural and fishery products as well as the shipment of incoming agricultural and fishery products at the port of entry and Cold Storage Warehouses;

NOW, THEREFORE, I, EMMANUEL F. PIÑOL, Secretary of the Department of Agriculture, by virtue of the powers vested in me by law, do hereby issue this Memorandum Circular creating the Technical Working Groups (TWG) — Monitoring and Evaluation Group and Inspection Group, that shall preserve the integrity of the Import Clearance and Inspection of Agricultural and Fishery Products at the first and second boarder.

- a) Creation of Technical Working Groups
 - SPS Inspection Group
 - SPS Monitoring and Évaluation Group

b) Composition

The members shall come from DA-OSEC other than the personnel from the Regulatory
Offices (Bureaus of Plant Industry, Bureaus of Animal Industry, Bureau of Fisheries and
Aquatic Resources and National Meat Inspection Service).

c) Functions

- SPS Monitoring and Evaluation Group
 - 1 Review the validity of SPS Import Clearances.
 - 2 issue corresponding certificate on the validity and authenticity of SPS import Clearance which will serve as one of the bases of the Agricultural Quarantine Officers for the release of the shipments.
 - 3. Review the current accreditation of Cold Storage Warehouses.
 - 4. Review the current accreditation of agricultural and fishery products Importers.
 - 5. Recommend policies to the Secretary that will improve the import clearances procedure.
 - 6 Maintain a database of agricultural and fishery product importers and Cold Storage Warehouses accredited entities included in the watchlist.

SPS Inspection Group

1. To validate pertinent importation documents of incoming shipments for release at the port of entry. List of importation documents attached and marked as follows:

Annex "C" Bureau of Fisheries and Aquatic Resources

- 2. To validate the Veterinary Quarantine and Meat Inspection Laboratory Certificate for products to be released at the Cold Storage Warehouses.
- 3. To inspect products at the port of entry and the Cold Storage Warehouses.
- 4. To report their findings and recommendations to the Office of the Undersecretary for Operations.
- 5. To report findings of violations to the Office of the Undersecretary and immediately refer the same to the quarantine Officer concerned to effect appropriate action.

d) Mechanics

- The importers shall submit to the SPS Monitoring and Evaluation TWG their request for validation and authentication, to which the SPS Monitoring and Evaluation TWG shall issue the corresponding Certificates.
- Upon effectivity of this Circular, prior to the release of the imported items a certificate of validity issued by the TWG shall be a mandatory requisite.

e) Separability and Repealing Clause

- If any portion or provision of this Memorandum Circular is declared invalid or unconstitutional, the other portions or provisions not affected thereby shall continue to be in full force and effect.
- All existing laws, decrees, executive orders, and rules and regulations or parts thereof

,		
which are inconsistent with this Circular, are h	hereby repealed or modified acc	cordingly.
f) Effectivity		
This Circular shall take effect fifteen (15) o	days after its complete publica	ition in the
\int_{1} official gazette or in two (2) newspapers of ge	eneral circulation, whichever co	nes first.
