**Subject : ACCREDITATION OF MEAT ESTABLISHMENTS IN BRAZIL TO EXPORT
POULTRY MEAT AND POULTRY MEAT PRODUCTS TO THE PHILIPPINES**

Whereas, the Philippines Department of Agriculture Mission to Brazil, after thorough investigation and evaluation of animal health status, quarantine procedures, meat inspection system, and meat establishments in Brazil, found favorable conditions that merit allowing importation of poultry meat and poultry meat products from Brazil;

Whereas, importation of poultry meat and poultry meat products from meat establishments stated in [Annex A](#) shall be allowed;

NOW, THEREFORE, I, LUIS P. LORENZO, JR. Secretary of Agriculture, by the powers vested in me by law, do hereby issue an order granting accreditation of meat establishment listed in Annex A to export poultry meat and poultry meat products to the Philippines.

All import transactions of the above mentioned products shall be in accordance with existing rules and regulations of the Department of Agriculture - Bureau of Animal Industry - National Meat Inspection Commission (DA-BAI-NMIC).

This ORDER shall take effect immediately.
