KYONGNAM PIG FARMER COOPERATIVE, LOTTE HAM COMPANY LIMITED, AND N. A. C. F MOGUCHON KIMJE MEAT PROCESSING PLANT, TO EXPORT PORK AND ITS BY-PRODUCTS INTO THE

PHILIPPINES FROM SOUTH KOREA

WHEREAS, the Philippine Department of Agriculture Inspection Team to the Republic of South Korea, after thorough investigation and evaluation of the disease situation, quarantine that merit plants, found favorable condition that merit allowing the importation of pork and its by products from South Korea.

- 4. N.A.C.F. MoguchonKimje Meat Processing Plant (Est. No. 196-SH) N.A.C.F. MoguchonKinje Meat Processing Plant (Est. No. 195-PP)
 - Pig skin not available at Lotte Ham Limited and N.A.C.F.MoguchonKinje Meat Processing Plant because of the absence of equipment and for its operation.
- **WHEREAS**, All import transactions of the above products shall be in accordance with the existing rules and regulations of the Department of Agriculture, Bureau of Animal Industry and National Meat Inspection Commission (DA- BAI- NMIC).
- **WHEREAS**, all imported products shall follow the existing standards/regulations of DA-NMIC labeling.

NOW, THEREFORE, I, EDGARDO J. ANGARA, Secretary of Agriculture, by the virtue of power vested in me by law, do hereby issue order granting accreditation of above stated meat plants to export pork and itsby products.

All orders, rules and regulations or parts thereof which are inconsistent with the provisions of

this order are hereby repealed or a	amended accordingly.
