Subject: ACCREDITATION OF TWENTY SEVEN (27) POULTRY PROCESSING

**PLANTS** 

FROM THAILAND

WHEREAS. the Philippines Department of Agriculture Mission in Thailand conducted thorough,

inspection, investigation and evaluation of twenty seven (27) poultry processing plants including an assessment of the disease situation in the sources of poultry, good

manufacturing practices and standards in the country found favorable conditions that merit

allowing the importation of the herein described products.

WHEREAS, the result of the above inspection, investigation and evaluation satisfies Philippines

conditions/ requirements for poultry plant accreditation.

NOW, THEREFORE, I, EDGARDO J. ANGARA, Secretary of the Department Agriculture, do hereby issue this accreditation of poultry processing plants, and guidelines governing the importation of fresh frozen chicken, frozen chicken parts, further processed/cooked chicken products from Thailand, to wit:
