SUBJECT: Accreditation of Meat Exporting Establishments of Austria and Finland to Export Meat and Meat Products into the Philippines

WHEREAS, paragraph A, Section IV of AO 39, Series of 2000, otherwise known as "Amended Rules and Regulations Governing the Importation of Meat and Meat Products into the Philippines" requires the accreditation of Foreign Meat Establishments (FMEs) before being allowed to export meat and meat products into the Philippines;

WHEREAS, the Department of Agriculture Mission in Austria and Finland, after thorough investigation and evaluation of the animal disease situation, meat inspection system, and meat processing system, has found favorable conditions that merit allowing importation of pork/poultry meat and meat products from Austria and Finland;

NOW, THEREFORE, I, LEONARDO Q. MONTEMAYOR, Secretary of Agriculture, by the power vested in me by law, do hereby accredit Austria and Finland Meat Exporting Establishments which are stated hereunder, *to wit*:



Hence, the following conditions are set forth, to wit:


1. That the above cited Austrian and Finland accredited FMEs are allowed to export meat and meat products to the Philippines, except meat and meat products derived from cattle and other ruminant as per AO 19, Series of 2000;
2. That all shipments from these accredited FMEs shall be in accordance with the provisions of AO 39 and 56, Series of 2000.
3. Further, all importation of pork/poultry meat and meat products shall be accompanied by:
 - a) Veterinary Quarantine Clearance (VQC) or Sanitary and Phytosanitary (SPS) Certificate from the Bureau of Animal Industry (BAI)
 - b) International Veterinary Certificate (IVC) issued by the Austrian Federal Veterinary Services, and Finland National Food Agency;
 - c) Other supplemental certifications on pathogenic/parasitic microorganisms (i.e. Salmonella and Trichinella), veterinary drugs, pesticides, hormonal residues and heavy metal contaminants.


All orders, rules and regulations or parts thereof which are inconsistent with the provisions of this Order are hereby repealed or amended accordingly.

This Order shall take effect immediately.
