**SUBJECT: AMENDING THE REVISED SCHEDULE OF FEES AND
CHARGES FOR THE SERVICES RENDERED BY THE ANIMAL
HEALTH DIVISION OF THE BUREAU OF ANIMAL INDUSTRY**

Pursuant to Executive Order No. 197, directing all Departments, Bureaus, Commissions, Agencies, Offices and Instrumentalities of the National Government including government-owned or controlled corporations to increase rates of fees and charges by not less than 20 per cent, the following shall be imposed by the Animal Health Division of the Bureau of Animal Industry for services rendered.




