SUBJECT:

AGREEMENT OF JIN-II INDUSTRIAL COMPANY LIMITED, PUSAN KYONGNAM PIG FARMER COOPERATIVE, LOTTE PIG COMPANY LIMITED, AND N.A.C.F. PRODUCTION REMAIN WHAT PROCESSING PLANT, TO EXPORT PORK AND ITS BY-PRODUCTS INTO THE PHILIPPINES FROM SOUTH KOREA

WHEREAS, the Philippine Department of Agriculture Inspection Team to the Republic of South Korea, after thorough investigation and evaluation of the disease situation, quarantine procedures, meat inspection system, meat plants, found favorable conditions that merit allowing the importation of pork and its by products from South Korea.

WHEREAS, only specified meat and by products such as pork, liver, backfat, skin, intestine coming from following slaughterhouses and its processing plants are allowed to be imported:

1. Jin II Industrial Co., Ltd. (Est. No. 101-S11)
 Dae Seong Foods Co., Ltd. (Est. No. 51-PP)
2. Pusan Kyongnam Pig Farmers Cooperative (Est. No. 116-S11)
 Pusan Kyongnam Pig Farmers Cooperative (Est. No. 69-PP)
3. Lotte Ham Co., Ltd. (Est. No. R-15-S11)
 Lotte Ham Co., Ltd. (Est. No. 154-PP)
4. N.A.C.F. Blogechon Kinsje Meat Processing Plant (Est. No. 196-S11)
 N.A.C.F. Blogechon Kinsje Meat Processing Plant (Est. No. 195-PP)

* Pig skin is not available at Lotte Ham Limited and N.A.C.F. Blogechon Kinsje Meat Processing Plant because of the absence of equipment and facilities for its operation.


WHEREAS, all import transactions of the above products shall be in accordance with the existing rules and regulations of the Department of Agriculture, Bureau of Animal Industry and National Meat Inspection Commission (DA-BAI-NMIC).

WHEREAS, all imported products shall follow the existing standards/regulations of DA-NMIC labeling.




All orders, rules and regulations or parts thereof which are inconsistent with the provisions of this order are hereby repealed or amended accordingly.
